Immediately following the adjournment of the Public Hearing, Council will convene a Regular Meeting during which it will give consideration to the items on the Public Hearing agenda.

The purpose of the consent application is a lot addition to transfer 287 square metres of land from the easterly property (Lots 86/87, Plan M75) to the westerly property (Lot 88, Plan M75). This consent will result in two lots of 689



square metres and 752 square metres in area and facilitate the development of one semi-detached building on each lot, each with 4 additional residential units (total of six units per building).

The purpose of the concurrent Zoning By-law Amendment is to rezone the westerly property from Residential One (R1) to Residential One, Special Exception (R1-XX) to permit a reduced corner lot area from 800 square metres to 689 metres and to reduce the rear yard setback from 7 metres to 4.3 metres. The Zoning By-law amendment is also to rezone the easterly property from Residential One (R1) to Residential One, Special Exception (R1-XX) to recognize Annette Street as the front lot line, and to permit 3 driveways and a reduced distance of 5.2 metres between driveways on the same lot (along Merritt Street).

is looking forward to representing the region at an all-expenses-paid national agricultural competition in Toronto later in the year.


Born and raised in Massey, she developed a strong passion for both dairy cows and horses through 4-H and working on farms.

New School Construction Underway For Manitoulin Island School

By Rosalind Russell - A Manitoulin Island First Nation has begun construction of a new school.

According to the release, construction has started on Sheshegwaning First Nation by the Sudburybased company Prosperi Construction.

The school will house grades Kindergarten to Grade eight in an over 18,000 square foot building.

The project is being funded through Indigenous Services Canada and is expected to open in January of 2027.

The board will also be looking for new names for the new space as construction draws near to completion.

Currently students are sharing space at the St. Joseph's Anishinabek School.

A Trilingual Version Of Our National Anthem



By Rosalind Russell - A local film/music producer has assisted a First Nation songstress in professionally producing a trilingual version of our national anthem.

Jayson Stewart, who is also a teacher at Espanola High School, has assisted Whitefish River First Nation member and singer, Mary Bryton Nahwegahbow, on the recorded trilingual version of O Canada, sung in Anishinaabemowin, English and French.

She says she auditioned for the Little Native Hockey League back in 2017 and changed up the lyrics at that time to

compete, progressing from there to sing her version at the 2017 North American Indigenous Games, and for national leagues including the Blue Jays and the Senators, conferences and other gatherings.

She also sang it at the Canadian governments' cabinet swearing-in ceremony at Rideau Hall in Ottawa this year, which garnered her national attention.

Stewart says the first verse is English, second French and the third in Anishinaabemowin.

He says copies of it will be made available to all schools and any other organizations that reaches out for a copy.
