NOTICE OF A PUBLIC MEETING Concerning Applications for Consent

TAKE NOTICE that the Council of the Corporation of the Township of Sables-Spanish Rivers will hold a public meeting to consider the proposed applications for Consent under Section 53 of the Planning Act, RSO 1990 as amended. The public meeting will be held on **Wednesday, April 26, 2023 at 6:30 p.m.** in Council Chambers, at 11 Birch Lake Road, Massey, Ontario unless Covid-19 restrictions require Council to meet electronically.

Consent File No. C-23-01 Purpose and Effect: To provide for a lot addition within the Residential zone. The property is described as Salter Township, Section 25, Plan D264, Units 5 and 6, Cameron St, Massey. The land in subject application is not subject to any other Planning Act application.

Consent File No. C-23-02 Purpose and Effect: To provide for the creation of a new lot within the Rural zone. The property is described as Victoria Township, Section 23, Parcel 23.2. The land in subject application is not subject to any other Planning Act application.

TAKE NOTICE that if you wish to be notified of the decision of the Township of Sables-Spanish Rivers on the proposed application, you must make a written request to the Clerk of the Township of Sables-Spanish Rivers. To appeal the decision to the Local Planning Appeal Tribunal, send an appeal form to the Clerk of the Township of Sables-Spanish Rivers outlining the reasons for the appeal. You must enclose the applicable appeal fee for each application appealed, paid by cheque, made payable to the Ontario Minister of Finance.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Township of Sables-Spanish Rivers to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at the public meeting or make written submissions to the Township of Sables-Spanish Rivers before the bylaw is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at the public meeting, or make written submissions to the Township of Sables-Spanish Rivers before the decision is made, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal, unless in the opinion of the Tribunal, there are reasonable grounds to do so.

NOTICE OF A PUBLIC MEETING

The Council of the Township of Sables-Spanish Rivers will hold a public meeting on April 12th, 2023, at 6:30 p.m. at the Massey & District Community Centre & Arena, 455 Government Road, Massey, ON, to hear comments, questions, and concerns from ratepayers regarding proposed Bylaws 2023-13 and 2023-14.

The purpose of Bylaw 2023-13 is to amend the current Zoning Bylaw 2003-15 to permit temporary habitation in a recreational vehicle on a lot with a primary residential use, and on vacant lots within the Resource Recreational (RR) and Rural (R) Zones. The amendment applies throughout the entire Township.

The purpose of Bylaw 2023-14 is to license recreational vehicles (trailers) in the Township of Sables-Spanish Rivers.
